E-bike for hire

Alton Town Council successfully applied for a grant to purchase an electric bike which will be available for hire to anyone interested in trying one out. At this early stage many details are still to be determined, such as the terms and conditions of hire, and even whether the bike will be a standard electric one or an e-cargo bike. The bike is due to be delivered soon and more information will be given out in due course.

This fulfils ATC's commitment to promote electric bikes as specified in their Climate Change Strategy Action Plan 2020-2023, updated in October 2020.

New Highway Code

A revision of the Highway Code is to be published on 29th January, following a public consultation last year after advice on wording suggested by Cycling UK. The update will include a new hierarchy of road user. For the first time in Britain the law will recognise that those who pose the greatest risk on our roads to others have a higher level of responsibility. This means someone cycling will have greater responsibility to look out for people walking, while someone driving would have greater responsibility to look out for people cycling, walking or riding a horse.

New hierarchy of road users

Old rule

Other key amendments in the new Highway Code include:

- Clearer guidance for drivers overtaking people cycling to give at least 1.5m;
- Guidance on how drivers and passenger can prevent 'cardooring' cyclists by using the 'Dutch Reach';
- Simplification on rules related to non-signalised junctions to prevent "left-hook" collisions, bringing Britain in line with similar laws on the European continent.

The new rules have legal implications and it's essential the public is informed about them. The government has announced a publicity campaign will be launched simultaneously with the new Highway Code rather than in the lead-up to it.

Cycling UK believes the Highway Code changes need a long term and well-funded communications campaign to help make the roads safer for everyone. However, news of the changes has started to be reported by the media in news and radio programmes, but a recent poll by the AA of 13,000 of its members worryingly found 2 in 3 knew nothing of the changes.

Consultation on Barriers to Cycling

Steve Willoughby of Hampshire County Council's Economy, Transport & Environment Department is asking cycling groups around Hampshire to report back to him by the end of January about any barriers to cycling in each local area. His brief is to develop a position statement for HCC on the use of 'No Cycling', 'Cyclists Dismount' and 'End of Route' signs, as well as the use of staggered barriers on walking and cycling routes, to avoid their use unless absolutely necessary on safety grounds.
