#### 20mph Speed Limit Survey closes 12th September

There is still time to respond to Hampshire County Council's (HCC) speed limit survey. They want to hear from as many residents as possible to find out their views on 20mph limits in Hampshire.

The findings from the survey, together with other data, will be important in helping to shape HCC's future policy on 20mph speed limits. The survey runs until 12<sup>th</sup> September and takes about 15 minutes to complete.

## E-Bike Loan from Alton Town Council

ATC has secured a grant from HCC for use of an e-bike for a year. Local residents can borrow it free-of-charge for up 10 days to try out.

The bike is a Carrera Crosscity folding electric bicycle, and is bookable on the ATC website:

It's now fully booked until December, but there are bookable dates next year until June.

In May, the government announced Cycling UK would run a national e-cycle support programme, and a trial loan scheme has now launched in Manchester. Smaller towns like ours would never normally receive funding for such a scheme as this, so we're fortunate to have this opportunity.

The government's target is for half of all short trips to be walked or cycled by 2030 in England. In 2019 over 60% of

trips between 1-2 miles were driven. E-bikes are a good alternative for short journeys like these. Research shows, however, that most people would cycle more if there was better investment in infrastructure, secure cycle parking, e-bike subsidies and charging networks.

#### Should bicycles have number plates?

It's been hard to miss the recent furore caused by Transport Secretary Grant Shapps' suggestion that bicycles should display number plates in order to identify the rider in case of law-breaking. He immediately backtracked and the DfT has since confirmed there are no plans to introduce such a retrograde policy. The government wishes to encourage cycling, not further regulate it.

This came just a few months after the Government confirmed last December that it had no plans to force cyclists to wear identification, among other things, as it had been urged to do by a petition published by solicitor Nick Freeman, known as 'Mr Loophole' for his securing acquittals of drivers accused of motoring offences, often on a technicality.

The Government considers that the costs of a formal registration system for cycle ownership would outweigh the benefits. The safety case for such a system is not as strong as that for drivers since, by contrast with motorised vehicles, cycles involved in collisions on the highway are highly unlikely to cause serious injury to other road users.

As Selaine Saxby MP, co-chair of the All-Party Parliamentary Group on Cycling & Walking says, "If we are to decarbonise our transport, cycling and walking are clearly part of the solution, not the problem."
